News & Announcements:

- ❖ **Resolution to Support Extending Blanket Distance Education Addendum to Summer 2020:** To plan for the likelihood of the current campus closures extending through summer 2020 quarter, at the April 21st meeting CCC passed a resolution in support of extending the Emergency Blanket Distance Education Addendum that Foothill previously submitted to the state Chancellor's Office. Extending the addendum will allow us to continue to offer online delivery of our courses that are not already approved to be taught via Distance Ed. This new resolution has been posted on [the CCC Policies & Resolutions webpage](#). Conversations regarding fall 2020 quarter classes will continue at the next meeting.
- ❖ **Upcoming addition to Foothill GE:** The following course was approved on April 21st for Foothill GE for 2020-21:

- ❖ **Certificates of Achievement:** On April 21st, CCC approved the applications for the following certificates of achievement: Audio Post Production, Game Audio I, Residential Wireman, Songwriting, Sound and Communication Installer. These programs are currently offered as non-transcriptable certificates and are being converted into certificates of achievement. Each will be sent to the FHDA Board of Trustees for approval at an upcoming meeting.
- ❖ **Noncredit Certificate:** On April 21st, CCC approved the application for the Bridge to College Level English Certificate of Competency, which will be sent to the FHDA Board of Trustees for approval at an upcoming meeting.
- ❖ **Foothill GE List for 2020-21:** The draft Foothill GE list for next year was presented at CCC. To review the list, please ask your CCC Reps. If you have any questions or notice any discrepancies, notify your Reps and/or the Curriculum Coordinator.
- ❖ **State Approval Received:** We recently received state approval for the Film, Television, and Electronic Media Certificate of Achievement, which was approved by CCC during winter quarter. Congratulations to the Media Studies department!
- ❖ **Ad Hoc Groups:** At the April 21st meeting, CCC held a second read of three Proposals to Create New Ad Hoc Committees: Curriculum Best Practices, Foothill General Education Process, Honors Institute Course Prerequisite. CCC approved the proposal to create the Honors Institute Course Prerequisite group, which has been posted on [the CCC Policies & Resolutions webpage](#).
