- ❖ Foothill GE Application Criteria: As teased in the previous edition of the communiqué, a top priority for CCC this year is refining the criteria for each area of the new Foothill General Education pattern, and updating our GE application forms to reflect the finalized criteria. These forms are used by faculty to submit courses for inclusion in the Foothill GE pattern, and they're also used to assess students' requests for GE course substitutions (our current forms, which are being used temporarily, may be found on the CCC Curriculum Process Resources webpage). At the October 21st meeting, Ben announced a plan for CCC to discuss specific areas/forms at each of the upcoming seven meetings:
 - November 4th: Area 1A English Composition & Area 1B Oral Communication and Critical Thinking
 - Note: in addition to the two GE areas being discussed at this first meeting, CCC will begin discussing the Breadth Criteria listed on all GE application forms
 - November 18th: Area 2 Mathematical Concepts and Quantitative Reasoning
 - December 2nd: Area 3 Arts and Humanities
 - January 20th: Area 4 Social and Behavioral Sciences
 - February 3rd: Area 5 Natural Sciences (with Laboratory)
 - February 17th: Area 6 Ethnic Studies
 - March 3rd: Area 7 Lifelong Learning

State Regulatory Revisions to Course Outlines of Record: Title 5 regulations related to the COR were recently revised, outlining new requirements for local curriculum processes and adding to the list of

information colleges are required to include on publicly available CORs. The good news is that CCC anticipated most of these revisions, so we are already either in compliance or putting processes in place to make sure we'll be in compliance by the deadline set by the state. CCC will continue discussions as needed on these Title 5 revisions; if you have any questions or would like more information, feel free to reach out to Ben.
