 - i. Office of Instruction – Campus is no longer under a state of emergency. Busy with scheduling and scrambling for which courses have official approval to be taught distance learning.
 - ii. Administration Building – EEOC meetings happening once a week.
 - iii. Campus Center – Pacific Dining's hours have shifted to staying open Monday to Thursday to 2:30 pm and 1:30 pm on Fridays. Student government is meeting, trying to have a hybrid format, but for now, students are hanging out in the ASFC offices. Rick Edwards has opened the print shop for any staff members who want to get their ID. Lastly, the middle college offices are being used by students. Ant problem in the central campus areas, but area has been treated with spray. Police Department will not be giving tickets this quarter, however placing warning tickets on cars for cars parked in undesignated areas.

- iv. Professional Development – Andre M. is working with Carolyn Holcroft to sign ten Classified staff up for the webinar in December. Also, looking for other professional development ideas.
- v. Sunnyvale Center – Center is closed except for EMT.
- vi. Student Resource Center – The DRC and VRC had a physical presence in admissions and records with the Student Services department. They are back to providing services virtually and having counselors utilize their office without students in the building.
