Origins

- The Institutional Effectiveness Committee was a discussion item at the April 19, 2024 MIPC meeting.
- Minutes indicate that this proposal would be brought back at a future MIPC meeting for approval.





Why an Institutional Effectiveness Committee?

- Assess institutional-level planning documents (review, updates)
- Facilitate discussion about institutional-level initiatives, efforts
- Promote program coordination and collaboration efforts
- Focus on continuous improvement in assessment, planning, student learning.
- Support integrated systemic efforts in a participatory governance environment

Why an Institutional Effectiveness Committee?

Why an Institutional Effectiveness Committee?

 improvement.

 A highly developed institution...regularly communicates that achievement...to continually seek opportunities for improvement.



Charge

 The Institutional Effectiveness Committee serves to promote ongoing and continuous improvement through the evaluation and assessment of college processes that supports the mission and advance institutional quality.

This committee meets every 3-4 weeks and reports to MIPC.





Committee Functions

- Provide ongoing evaluation of processes (not alignment)
- Support institutional planning
- Foster collegiality and robust dialogue about institutional effectiveness
- Establish transparent and consistent communication of institutional progress towards its goals
- Make recommendations to MIPC





What would the IEC do?

- Maintain and update college planning calendar
- Evaluation of improvement processes
 - Program review, governance, 13-55, resource prioritization, guided pathways, learning outcomes, etc.
- Evaluation of college planning
 - EMP, Facilities Master Plan, Tech Plan, Distance Ed, etc.
- Accreditation
 - Institutional Set Standards (effectiveness + methodology)
 - Midterm report, ISER, Follow up report

- Sunshine institutional-level planning documents
- Sunshine institutional-level improvement efforts
- Support governance evaluation
- Support program review evaluation
- Support budget request process evaluation
