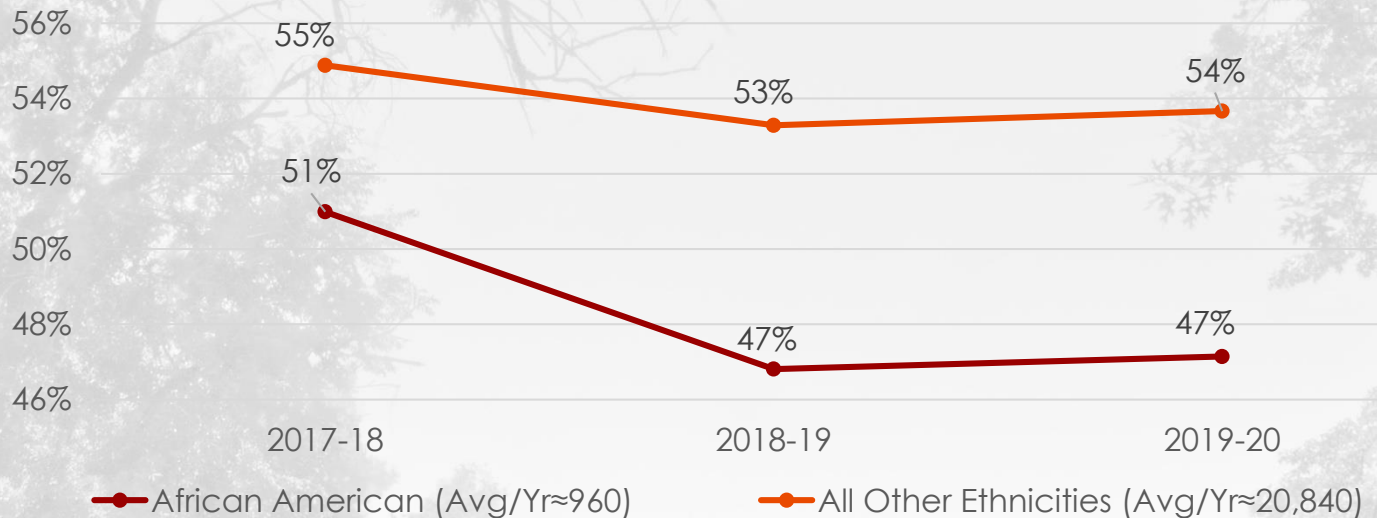




# Admissions & Records: Application to Enr Yield Rate

**WHAT THIS MEANS:** ~6% fewer (first time/returning) Black/African Americans enroll in same term of application compared to all other ethnicities (n=~99)

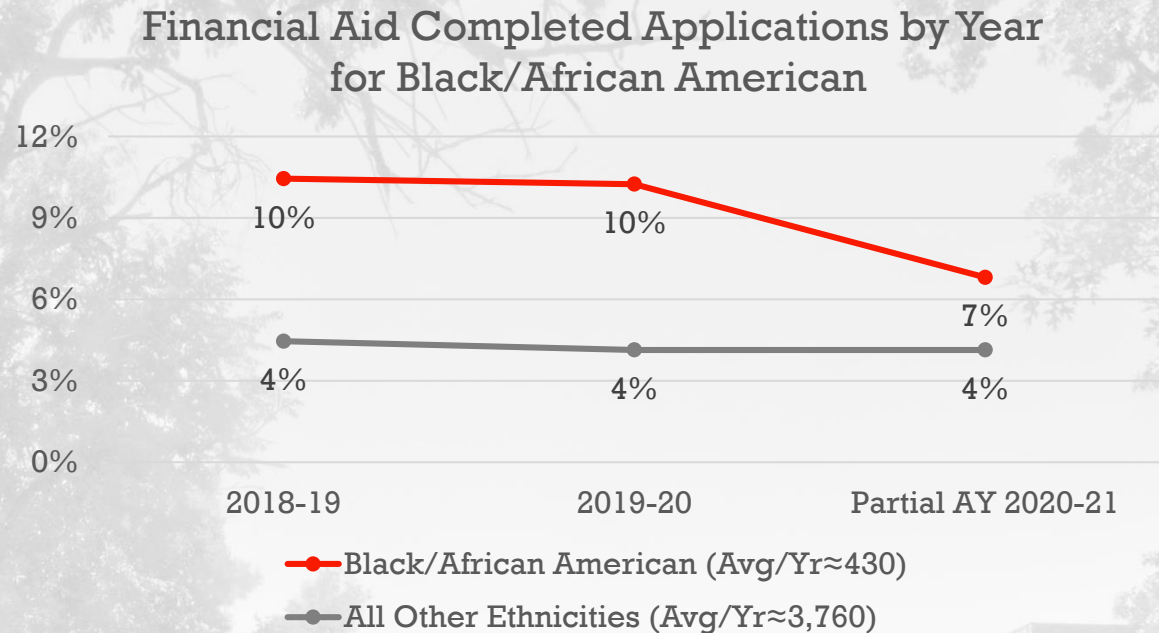

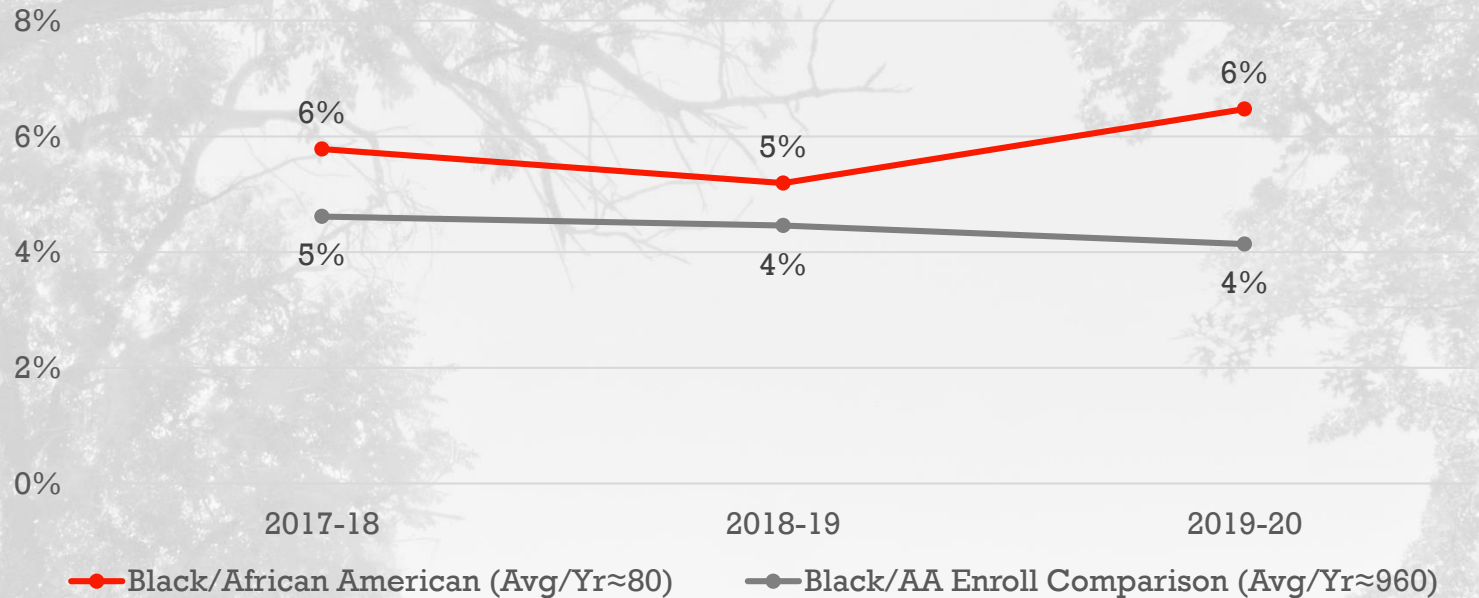

Disability Resource Center Active Intakes by Year for Black/African American



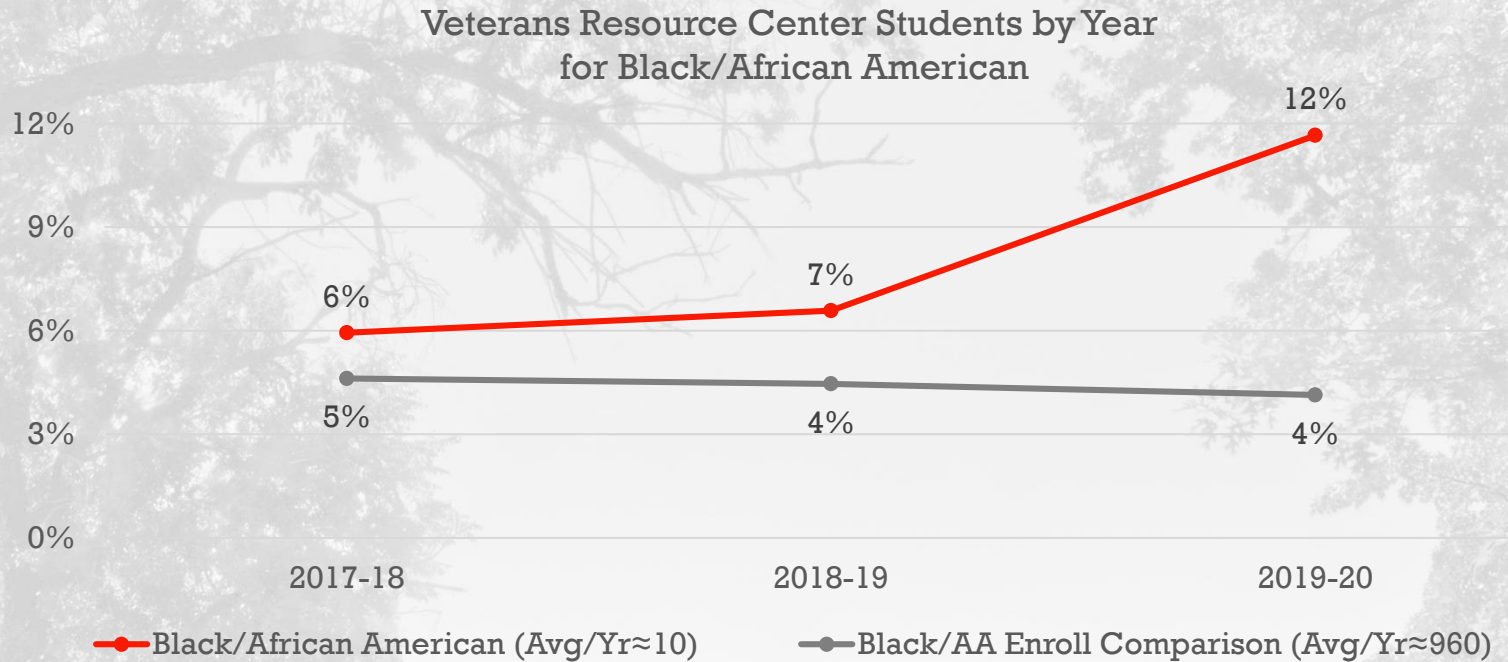

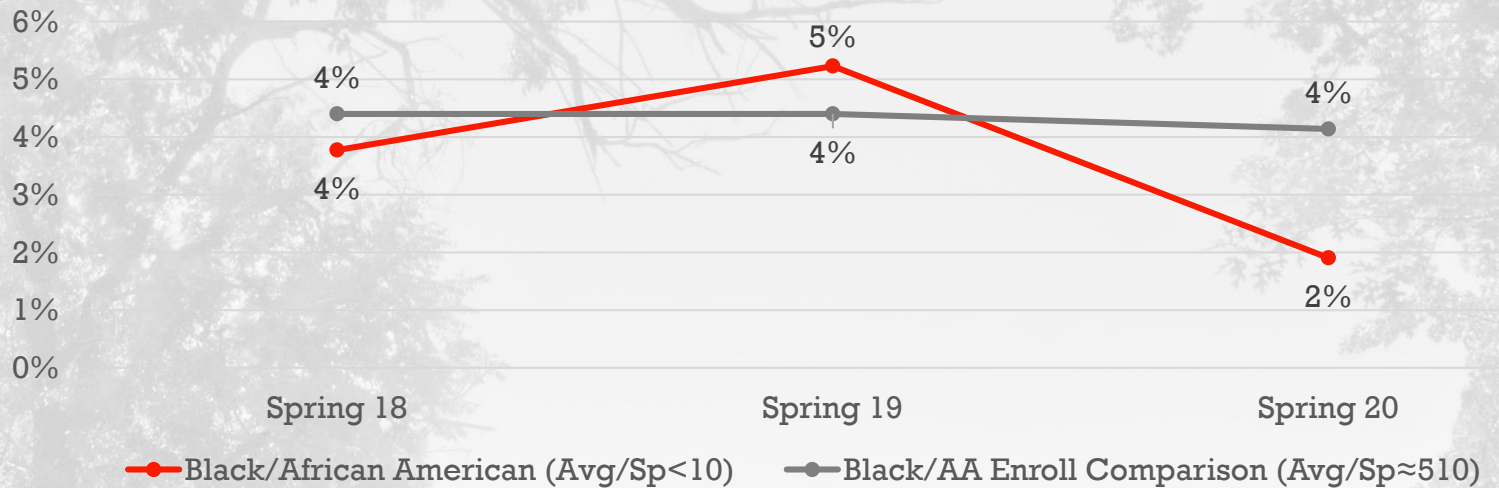
