Although FTES might have decreased, I find it difficult to blame the program or the writer. how graduates might turn down these jobs in favor of aiming for the higher wage jobs, but hopefully they are also considering that gaining experience will increase their chances for the higher wage jobs (especially for the young students on the track out of highschool). What % of your students who don't find employment are actually entering into programs for more advanced degrees, such as Pharmacy School? Is it possible the low employment % is partly an artifact of students who aren't seeking employment at the time they graduate? I imagine that having a PharmTech certificate increases your competitiveness for highly sought after slots in Pharmacy School. Regarding the recommendations from the Accreditation Team, one that stood out to me was the need for the program director to have more release time, given the extensive duties they perform. I want to put in a plug for this to happen permanently for the program director, rather than temporarily while revising the curriculum for the new certificate pathways. This is an impressive program!

from those creating the Program Review to be straightforward and logical, sometimes a one-size-fits-all is hard to achieve and squeezing circles into squares still takes place. Now we all have a totally new dynamic to face with the Shelter-in-Place and ramifications to address. I am optimistic that the college will be able to rally to address future challenges especially with the support of funding from Measure G. In my training to prepare for being a reader, I was informed that these Program Reviews would be used by Foothill to determine where to spend money to make improvements. From my view, there was no hint that structural, organizational or monetary tools/suggestions could be suggested. Perhaps a question like, "if you were to suggest a departmental approach in improving the success of American Natives, what would you like to see?" Encourage talk of working with either more than one program or division to combine resources or monies to achieve a particular goal. Or ask if their program can pointing out a successful attribute of another (rival?similar? outside?)program of Foothill and request it be implemented in their program. For example x program has its own computer lab and we would like one too. Or, talk about the elephant in the room such as: "Marketing is asked to bare the burden to improve percentage of x minority in this program. What ways can you suggest to work with marketing to improve percentage of x minority in this program?" Don't get me wrong, this Program Review I find an improvement over previous versions. Maybe there can be other ways to encourage positive collaboration.
